CENTUNION, S.A. is a Spanish engineering company dedicated to the design and construction of industrial plants and infrastructures, which normally assumes the functions of general contractor, coordinating and taking responsibility for the various technical, economic and financial stages of the projects.

One of its main activities is the Engineering, Design, Supply and Construction of Bridges, an activity to which CENTUNION wants to provide continuous and determined support to make the most of its experience in this field, and to cover the needs of terrestrial communication in those countries and places with great deficiencies in this type of infrastructure.

Aware of the importance of quality and respect for the environment in which we live, CENTUNION has implemented an Integrated Quality and Environmental Management System applied to Engineering, Design, Purchasing Management, Project Management and Turnkey Projects, in relation to the supply and construction of bridges, complying with the requirements of the UNE-EN ISO 9001:2015 and UNE-EN ISO 14001: 2015 standards.

Integrated into this management system, CENTUNION establishes, develops and reviews its Integrated Quality and Environmental Policy, focused on obtaining the full satisfaction of our customers and the utmost respect for the environment.

We understand the protection of the environment as an important responsibility of the management and we ensure that this is carried out through concrete goals and guidelines of behavior in all functions and areas of activity of the company.

Environmental protection requires responsible behaviour on all of us.

We understand that the reduction of the environmental impacts generated in the execution of our projects, the consumption of water and energy, as well as the improvement in the realization of the environmental indications that will include the projects, is the central task of our environmental protection policy.

We guarantee, through the appointment of a person in charge of the environmental management system, the consideration of the current legal requirements regarding environmental protection in the decisions of the company and their application through the measures that are adopted. We are openly committed to complying with these legal requirements.

CENTUNION understands that the customer does not buy only a product but a whole series of services, so to achieve their full satisfaction and our correct environmental behaviour, the following principles will be followed:

- Rigorous compliance with all requirements that affect the project, both those of the client, stipulated in the contracts, as well as the legal and regulatory ones that apply to the Design, Engineering, Supply and Construction of Turnkey Bridges, including environmental legal requirements or other requirements that Centunion voluntarily subscribes to.
- The supply of products and services to a customer must be focused on effectively meeting their needs.
- Customer and stakeholder satisfaction must be continued throughout the development of the project and remain after the project is finished. It must act with the utmost diligence and rigor in the response and / or resolution of any matter raised by the client.
- Acting in accordance with environmental legislation, standards and applicable guidelines, attending to the standards of excellence and environmental management systems, requiring our suppliers to have in force the iso 9001 and iso 14001 environmental certificates.
- Commitment to pursue continuous improvement while maintaining over time the principles of Quality and Environment in our activities.
- Extension of the principles of Quality and Environment to all the company personnel, subcontracted companies and suppliers, maintaining continuous improvement over time.

- Involving, training and holding accountable the people who make up the Organization so that they respect, share and apply the Environmental Management System, whether they are workers, suppliers or subcontractors.

The Integrated Management System has the commitment of senior management. The senior management of CENTUNION will put all the means at its disposal so that the Procedures and Processes that make up the Integrated Management System add value and are effective. A continuous improvement of the system will be pursued, through objective analysis and measurements and applying the appropriate corrective actions.

CENTUNION understands as essential aspects in the realization of projects for the Design, Engineering, Supply and Construction of Turnkey Bridges, the quality of the supplies, the correct environmental behavior and a strict control in the logistics of the transports to the work, as well as the establishment of the appropriate structure for the execution, supervision and control of the construction works. All this within the deadlines and budgets established in the contractual documents with our clients. To achieve these goals, the requirements that our suppliers and subcontractors must meet will be considered, maintaining with them a highly professional relationship based on trust and rigorous compliance with the respective obligations.

The General Manager of CENTUNION is primarily responsible for establishing and maintaining this Integrated Policy, through its control, periodic review, and ensuring the necessary resources to carry it out.

The Integrated Policy is applied at all levels of the organization, through using the Procedures established by the Integrated Management System.

The General Manager undertakes to communicate and explain the Policy, and that it is understood within the organization. The Policy is publicly presented and explained in the General Manager's timely meetings with all staff.

Within the framework of the Policy, Objectives and goals will be established at the proposal of the person responsible for quality and environment, which will be approved by the General Manager.
